The **WHITMAN HOUSING AUTHORITY**, the Awarding Authority, invites sealed bids from Contractors for the Knob & Tube Replacement at State Aided Development: Fullerton (705-1-002) in Whitman, Massachusetts, in accordance with the documents prepared by **ROGUE ENGINEERING AND DESIGN**.

The Project consists of but not limited to:
Electrical Upgrades at 46 Fullerton Ave, Whitman, MA, including removal of remaining knob-and-tube and BX wiring and replacement with code-compliant NM-B/MC cabling, grounded devices, and required GFCI/AFCI protection. Scope includes replacement of identified ungrounded/loose or otherwise malfunctioning receptacles, new circuiting to existing panels, grounding/bonding, identification, testing, and finish restoration (cutting/patching).

The project is specification-driven (no drawings) and carries base quantities of and additional work paid under unit prices per Section 01 22 00. All work shall comply with the 2023 NEC and applicable Massachusetts codes and standards.

The work is estimated to cost **\$33,564.00**.

Bids are subject to M.G.L. c.149 §44A-J & to minimum wage rates as required by M.G.L. c.149 §§26 to 27H inclusive.
