The **Whitman Housing Authority**, the Awarding Authority, invites sealed bids from Contractors for the **667-3 Window and Siding Replacement Project, #338080** in Whitman, Massachusetts, in accordance with the documents prepared by **Gorman Richardson Lewis Architects**.

The Project consists of: The removal and replacement of the existing windows and siding including but not limited to the installation of new vinyl windows, vinyl siding, cellular PVC trim, weather barrier, and sheet metal flashings at 5 buildings and where indicated on the Drawings.

The work is estimated to cost **\$916,100**.

Bids are subject to M.G.L. c.149 §44A-J & to minimum wage rates as required by M.G.L. c.149 §§26 to 27H inclusive.
